IMPORTANT CONVENTION INFORMATION:

- This convention is limited to 800 attendees. Registrants will be notified of their status via email or mail. Registrations will be processed on a first-come first-served basis.
- Registrations cannot be postmarked prior to July 15, 2018
- Registration forms must be sent via regular mail. Any mail requiring signatures will be refused.
- No more than 4 registrations per envelope. Provide 1 copy per registration.
- Registrants must be 13 years of age or older, prior to July 29, 2019.
- If I cancel for any reason prior to or on March 1, 2019 I will be refunded my registration price less a \$50 cancellation fee. Cancellations must be made in writing and sent to the address registrations were sent to or emailed to 2019BConvention@gmail.com.
- No refunds will be issued for any reason or at any time with respect to pre-paid convention related events, including but not limited to workshops, VIP passes, souvenir orders or raffle tickets.
- A \$30 service fee will be assessed for each returned check, regardless of the amount of the check. Service fees for all returned checks must be paid before any further convention communication occurs.
- In order to receive convention package souvenirs, including but not limited to the convention doll, I must be present at the convention event for the duration of the event, with my name badge, where the souvenir(s) are given out. No exceptions. I understand that I forfeit my right to receive the souvenir(s) if I am not present or if I leave the event early before the items are given. Registration badges may not be given or loaned to anyone for any reason. The badge may only be worn and used by the person whose name is on it. Anyone found in violation of this rule will immediately forfeit his or her right to attend any and all convention activities and will receive no additional convention gifts, including the convention doll.
- In the event of an occurrence of any circumstance beyond the control of the NBDCC, such as an act of God or disaster that makes it impossible to hold the NBDCC, each registrant agrees that he or she will receive a souvenir doll and any and all convention package souvenirs in the possession of the convention in lieu of cash refund of his or her registration fee. Registrant must be in good standing to receive convention package souvenirs.
